Terms & Conditions

1. The Promoter

Peku Peku Travel Services (The Promoter), with its primary social media handle being @pekupekutavel, hereby sets out the terms and conditions for this promotion. The Prize may be sponsored or fulfilled by a third party – Teremok Lodge & Spa.

2. The Prize

The Prize consists of one (1):

- Two night accommodation **for two people** on a bed and breakfast basis at Teremok Lodge & Spa in Umhlanga, off peak season. Valid until 31 July 2026.
- A two-course dinner **for two on one of the two nights**, excluding drinks.
- Free shuttle transfers to and from Umhlanga **during the 2-night stay**.
- Free return airport transfers from King Shaka International Airport, **exclusively for the 2-night stay**.

The Prize will be awarded to one person only and is subject to availability. It is non-transferable, non-refundable, and cannot be exchanged for cash or any other alternative.

Prize does not include flights to and from Durban, or any other transport costs not mentioned, or any meals not mentioned.

3. Eligibility

This competition is only open to South African residents aged 18 years and over. Employees, immediate family members, agents, or affiliates of the Promoter or Prize Giver are not eligible.

A valid entry must comply with **all** entry conditions (see below).

4. How to Enter

Entrants stand a chance to win by:

The decision of the Promoter is final, and no correspondence will be entered into.

6. Prize Fulfilment

The Prize must be taken up **during off peak season by 31 July 2026**. If the Prize becomes unavailable due to circumstances beyond the Promoter's control, the Promoter reserves the right to substitute the Prize with another similar getaway of equal or greater value. Prize value is R12 600 (all inclusive).

To the fullest extent permitted by law:

- The Promoter and/or Prize Giver shall not be liable for any loss, damage, or injury of any nature arising from the competition, or from the use of the Prize.
- The Promoter's total financial liability shall not exceed the cost value of the Prize.
